TEXAS HUNTING INCIDENT PROFILE

- Violated a cardinal rule of hunter safety – incidents were preventable
- Average age in the twenties
- Hunted deer with rifle; hog with handgun/rifle; or dove/quail with shotgun
- Was **not** under the influence of alcohol
- Did not attend a hunter education (safety) course or program
- Did not wear any type of hunter orange clothing
- Was situated in or around vehicle
- Sustained a non-fatal injury
- If not self-inflicted – incident was a caused by lack of judgment or skill
- Had over 10 years of hunting experience
- If self-inflicted – handled firearm carelessly; firearm fell
- Distance of muzzle to wound was within 50 yards, mostly within 10 yards
- Victim was in light to open cover with clear visibility (weather)
- Incident occurred towards dusk; fatigue a factor
- Incident occurred on weekend during September or November



2012 Significant Factors

- Fatalities up by three from 2011
- Swinging on Game incidents up from 2011
- Dove incidents at four-year high
- Incidents involving those under 40 up from 2010 and 2011
- Fewer hunter education graduates in the incident data
- Self-inflicted accidents down significantly
- Number of alcohol incidents down

<i>Prevention:</i>	Always point muzzle in a safe direction; treat every firearm as if it is loaded; handle firearms carefully; complete hunter education.

<i>Comments:</i>	Shooter was standing outside passenger door of vehicle. He had propped firearm against platform mounted on vehicle. Rifle slipped and discharged, first hitting his finger as he reached for falling gun, and then firearm hit the ground and discharged a second time hitting him in the groin. No visible exit wound.					
<i>Prevention:</i>	Treat every firearm as if it is loaded; handle firearms carefully; unload firearms before setting them against a stable rest; complete hunter education.

<i>Comments:</i>	Nine year old shooter and 12 year old victim were hunting together in a field. Shooter took aim at a flying bird that was overhead and behind the victim. The shooter stumbled and the gun discharged during the fall when the muzzle was level with the victim. The .22 bullet entered the right side of his chest and exited to the left side of the upper back.					
<i>Prevention:</i>	Always maintain muzzle control; make sure to identify the target clearly and what is in front of and behind the target before raising the sporting arm for a shot; know where others are positioned at all times; complete hunter education.					
12-30	Cameron	13/M	Rifle	Unknown	No	No
<i>Comments</i>	Shooter and victim were in the backyard. Shooter was shooting at birds. Shooter said the gun was not loaded or he stumbled. Bullet struck victim in the head, killing him.					
<i>Prevention</i>	Always maintain muzzle control; make sure to identify the target clearly and what is in front of and behind the target before raising the sporting arm for a shot; know where others are positioned at all times; complete hunter education.

<i>Comments:</i>	Shooter propped loaded shotgun against a fence to use the restroom. Victim was shot in the leg when the dog knocked over the shotgun.					
<i>Prevention:</i>	Always point the muzzle in a safe direction; unload firearms before setting them against a stable rest; use the safety; complete hunter education.

<i>Comments:</i>	Shooter hid shotgun under a duck blind when he thought a game warden was driving up because he was hunting without a license. When he realized it was not a game warden, he carelessly picked up the loaded shotgun which discharged hitting victim in the legs.					
<i>Prevention:</i>	Always point muzzle in a safe direction; treat every firearm as if is loaded; handle firearms carefully; use the safety; communicate with hunting companions; know where others are positioned at all times; complete hunter education; obey the law.

<i>Comments:</i>	Group of four shooters using a deer blind to hunt feral hog. Several shot as hogs approached, hitting victim who was in another deer blind.					
<i>Prevention:</i>	Always stay within a safe zone of fire; communicate with hunting companions; know where others are positioned at all times; make sure to identify the target clearly and what is in front of and behind the target before raising the sporting arm for a shot; apply what was learned in hunter education.

<i>Comments:</i>	Shooter placed revolver with all six rounds into oversized holster; revolver discharged and wounded him in leg.

<i>Prevention:</i>	Handle firearms carefully; control the muzzle at all times; use the safety; complete hunter education.

<i>Comments:</i>	Shooter discharged his shotgun at doves and towards victim who had pulled up to watch the hunters. The shot struck the truck and victim's mouth.					
<i>Prevention:</i>	Never fire across property lines or towards another property within the effective range of the firearm; obey the law; make sure to identify the target clearly and what is in front of and behind the target before raising the sporting arm for a shot; complete hunter education.

<i>Comments:</i>	Shooter shot at dove over stock tank. Victim had shot a dove and walked to retrieve a downed dove which put him in line of fire. Shot struck victim in face.					
<i>Prevention:</i>	Always stay within a safe zone of fire; communicate with hunting companions; know where others are positioned at all times; make sure to identify the target clearly and what is in front of and behind the target before raising the sporting arm for a shot; complete hunter education.

<i>Comments:</i>	Shooter was dove hunting with others. He was positioned about 50 yards behind the victim who was near a stock tank. Shooter shot at dove that flew between him and victim. Shot stuck victim in the forehead.					
<i>Prevention:</i>	Always stay within a safe zone of fire; communicate with hunting companions; know where others are positioned at all times; complete hunter education.

<i>Comments:</i>	Shooter and eight year old victim were hunting across from one another in a corn field. Victim was retrieving a downed bird when shooter attempted to engage another bird. Shot struck victim in torso.					
<i>Prevention:</i>	Always point the muzzle in a safe direction; make sure to identify the target clearly and what is in front of and behind the target before raising the sporting arm for a shot; know where others are positioned at all times; apply what was learned in hunter education.					
9-3	Mason	43/M	Shotgun	Dove	No	Yes
<i>Comments:</i>	Victim went to retrieve a downed bird when shooter fired at incoming dove. Shot peppered victim across torso, arms and legs.					
<i>Prevention:</i>	Always point the muzzle in a safe direction; always stay within a safe zone of fire; communicate with hunting companions; know where others are positioned at all times; apply what was learned in hunter education.

<i>Comments:</i>	Shooter/Victim was sitting with one leg bent and the other extended, and with shotgun resting across his lap, loaded, cocked and muzzle pointed toward his extended foot. He said the shotgun suddenly went off, striking him in the foot. He thought the gun went off because it got too hot.					
<i>Prevention:</i>	Handle firearms carefully; control the muzzle at all times; use the safety; apply what was learned in hunter education.

When rifle discharged, projectile entered from top of cab. Victim obtained minor injuries on the back of his head from metal shrapnel.

Prevention: Always point muzzle in a safe direction; always stay within a safe zone of fire; communicate with hunting companions and know where everyone is positioned at all times; never hunt from/on a vehicle; handle firearms carefully; recognize that muzzle is lower than scope and cannot be placed behind an object or on the ground; complete hunter education.

<i>Comments:</i>	Shooter's revolver failed to fire and discharged as shooter attempted to unload it.					
<i>Prevention:</i>	Handle firearms carefully; control the muzzle at all times; use the safety; apply what was learned in hunter education.

<i>Comments:</i>	Shooter laid loaded shotgun with safety activated on ground to take bathroom break. Hunting dog stepped on gun causing it to discharge. Shot struck hunter in ankle.					
<i>Prevention:</i>	Always point the muzzle in a safe direction; unload firearms before setting them against a stable rest; use the safety; apply what was learned in hunter education.					
12-14	Jim Wells	27/M	Rifle	Deer	No	Yes
<i>Comments:</i>	Shooter was hunting from elevated blind; victim was hunting from a ground blind. Shooter shot at a deer approximately 100 yards from his blind. Bullet apparently struck the ground near the deer and ricocheted down range, entering the blind and striking the victim. Victim received wounds in hand and groin.					
<i>Prevention:</i>	Know where others are positioned at all times; make sure to identify the target clearly and what is in front of and behind the target before raising the sporting arm for a shot; apply what was learned in hunter education.					
12-22	Llano	11/M	Rifle	Feral Hog	No	No
<i>Comments:</i>	Shooter and two other juveniles were given one 30-30 and told to go hunt for hogs and deer. Shooter stopped to use cell phone and attempted to eject all six rounds from the rifle, but failed to remove the last one from the chamber. Shooter pointed the rifle at the victim and shot him in the thigh, shattering his femur. Shooter insists it was an accident.					
<i>Prevention:</i>	Treat every firearm as if it is loaded; handle firearms carefully; always point muzzle in a safe direction; communicate with hunting companions and know where everyone is positioned at all times; complete hunter education.					
12-23	Presidio	21/M	Shotgun	Dove	Yes	No
<i>Comments:</i>	While attempting to cross a fence, shooter rested his loaded shotgun against the fence without the safety on. The shotgun slipped as he tried to cross the fence. He reached for the gun as it slipped and the shot struck him in the left hand causing severe injury.					
<i>Prevention:</i>	Always point the muzzle in a safe direction; unload firearms before setting them against a stable rest; use the safety; complete hunter education.
